## 3. Main title

The main title is centred, and in times new roman 14-point, boldface type. Capitalize the first letter of nouns, pronouns, verbs, adjectives, and adverbs; do not capitalize articles, coordinate conjunctions, or prepositions. Leave one blank lines after the title.

## 4. Author name(s) and affiliation(s)

Authors name are to be centred beneath the title and printed in times new roman 11-point, boldface type and centre. Please do write Authors' affiliation and address beneath of Authors name. It is in Times New Roman 10, Center and normal.

## 5. Main Text

Type your main text in 10-point Times New Roman, single-spaced and justified. Do not use double-spacing.

## 6. Figure and Table captions

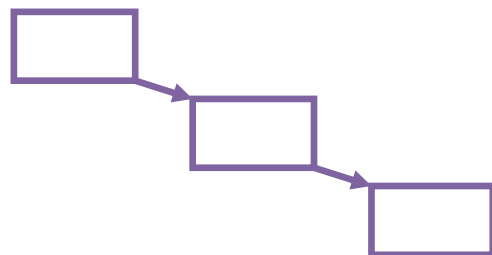
Figure and Table captions should be 10-point boldface centre times new roman. The First words are in capital and all other words are in small letters. Figures and tables must be numbered separately. Column heading should be 9-point boldface Centre times new roman. Column Values should be 9-point Justify times new roman and normal.

The name of the persons who made some significant contribution in improvement of the authors' paper will be included in the acknowledgement section. The sources of funding can also be included in this section. [Times New Roman 10, Justify]

### References

[Times New Roman 12 Bold, Centre]

It should be 9-point times new roman fully justified. Only cited text references are included. Each reference is referred to in the text by a number enclosed in a square bracket (i.e., [1]). References **must be numbered and ordered according to where they are first mentioned in the paper**, NOT alphabetically.

The references should follow the following Structure.

#### For Journal Reference

Author(s), "Article Title", Journal Title, Volume, Issue, Month-Year, Page(s).

#### For Conference Reference

Author(s), "Article Title", Title of Published Proceedings, Conference Title, Location, Date, Place of publication, Publisher, Month-Year, Page(s).

#### For Book reference

Author(s), "Book Title", Publisher City, Publisher Name, Month-Year, Page(s), Medium.

#### For Chapters in book reference

Author(s), "Section Title", "Book Title", Publisher City, Publisher Name, Month-Year, Page(s), Medium.

#### For Website reference

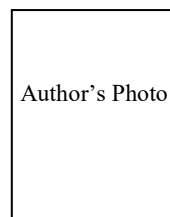
Author(s), "Article Title." Website Title, Publisher of Website, Day Month Year article was published, Day Month Year article was accessed. <URL>.

**Note: high-level publications should avoid references to web sites if at all possible. References should be to a permanent, unchanging source; web sites are ephemeral.**

Examples:

- [5] Author(s), "Article Title", Website Title, Publisher of Website, Day Month Year article was published, Day Month Year article was accessed. <URL>.

All authors should include short biographies with photo at the end of regular papers.



Author's Photo

All authors should include biographies with photo at the end of papers. The first paragraph may contain a place and date of birth. Next, the author's educational background is to be listed. They also pen down their professional membership, current position in the professional job, publications and achievements, etc.
